- b) Traders/suppliers could drop their own business Quotation to ASHIKA head Office within 02/03/2025 by 12.30PM and ASHIKA Authority will open dropped quotation within 3.30 PM in this date.
- c) The bidder provides their quotation on their business's pad/cash memo and mention to The Purchase Committee, ASHIKA Development Associates.
- d) The quotation should submit in a sealed envelope and mentioned to the subject line with advertisement number & category top of the envelope. Any bidder could bid single or multiple or all advertisement (if have related experience and business).
- e) The quotation should not be rubbed/ overwritten under any circumstances.
- f) The quotation should be added with all the costs (transport, service charge, VAT, tax if any). No separate bill can be submitted later.
- g) The bidder should submit a copy of updated trade license, Contractor License (for suppliers), VAT & Tax Certificate (if any) with tax return copy and latest Bank Solvency/one month bank statement along with the quotation. Quotation should be submitting as per advertisement details.
